Student Achievement Committee Meeting  
June 2, 2015

The Student Achievement Committee is reviewing the student achievement policies referred to it. The table below shows the status of the policies as of May 27, 2015. Where the notation "GBM" is used, it references the General Business Meetings where the full Board meets and takes action. Under Board of Education ("Board") processes, generally, a policy will go to the committee first. The committee will consider the policy and make a recommendation to the full Board. The committee can also defer action on a policy so that the policy stays in committee and does not move on for consideration by the full Board. If the committee makes a recommendation, the full Board can then consider the policy at a General Business Meeting. A policy will not be effective until the full Board takes action on it and approves the policy.
