General Business Meeting September 6, 2018

Pursuant to Hawaii Revised Statutes ("HRS") Section 302D-3(c), 1 entitled "[s]tate public charter school commission establishment; appointment," the Board of Education ("Board") appoints the members of the State Public Charter School Commission ("Commission"). The section further states that the Board shall "consider the combination of abilities, breadth of experiences, and characteristics of the commission, including but not limited to reflecting the diversity of the student population, geographical representation, and a broad representation of education-related stakeholders." Section 302D-3(d), HRS, further requires each nominee to the Commission to meet minimum qualifications. These minimum qualifications are:

- 1. Commitment to education. Each nominee's record should demonstrate a deep and abiding interest in education, and a dedication to the social, academic, and character development of young people through the administration of a high performing charter school system;
- 2. Record of integrity, civic virtue, and high ethical standards. Each nominee shall demonstrate integrity, civic virtue, and high ethical standards and be willing to hold fellow commission members to the same;
- 3. Availability for constructive engagement. Each nominee shall commit to being a conscientious and attentive commission member; and
- 4. Knowledge of best practices. Each nominee shall have an understanding of best practices in charter school educational governance or shall be willing to be trained in such.

Section 302D-3(e), HRS, provides that nominees shall also ideally meet the following recommended qualifications:

¹ Section 302D-3(c), HRS, provides:

[&]quot;The commission shall consist of nine members to be appointed by the board. The board shall appoint members who will be tasked with authorizing public charter schools that serve the unique and diverse needs of public school students. The chair of the commission shall be designated by the members of the commission for each school year beginning July 1, and whenever there is a vacancy. The board shall consider the combination of abilities, breadth of experiences, and characteristics of the commission, including but not limited to reflecting the diversity of the student population, geographical representation, and a broad representation of education-related stakeholders. The commission shall be exempt from sections 26-34 and 26-36."

- Experience governing complex organizations. Each nominee should possess experience with complex organizations, including but not limited to performance contract management, and a proven ability to function productively within them; and
- Collaborative leadership ability. Each nominee should have substantial leadership experience
 that ideally illustrates the nominee's ability to function among diverse colleagues as an effective
 team member, with the ability to articulate, understand, and help shape consensus surrounding
 commission policies.

At its July 19, 2018 general business meeting, the Board nominated Rogerlynn Akau, Mason Chock, Elena Farden, Matthew Kodama, Vanessa Ott, Roger Takabayashi, and Carl Takamura for appointment to the Commission. At its August 2, 2018 general business meeting, the Board deferred the appointment until it received input from the Commission's Executive Director. One nominee, Carl Takamura, subsequently withdrew his name from consideration. In response to the Board's request for input, Sione Thompson, Executive Director of the Commission, provided the Board with the letter dated August 31, 2018, attached as **Exhibit A**.

Of the six remaining nominees, the Board may appoint one to fill the current vacancy of the Commission, left by the resignation of Commissioner Mark C. Dillon on July 1, 2018, and to the remaining term effective immediately and ending June 30, 2020. The resumes of each of the nominees, as well as their cover letters or nomination letters, are attached as **Exhibit B**.






