("NASBE") election of NASBE chair-elect

## I. BACKGROUND

The Hawaii State Board of Education ("Board") is a member of the National Association of State Boards of Education ("NASBE"). NASBE develops, supports, and empowers citizen leaders on state boards of education to strengthen public education systems so students of all backgrounds and circumstances are prepared to succeed in school, work, and life. NASBE is holding its annual conference in Omaha, Nebraska from October 20 through 23, 2020.

NASBE members will be convening virtually to conduct the organization's business, including electing the 2021 NASBE Chair-elect.

At its September 17, 2020 General Business Meeting, the Board designated Board Chairperson Catherine Payne as the voting delegate and Board Member Lynn Fallin as the alternate delegate to represent Hawai'i and vote at the delegate assembly.

The position of NASBE chair-elect is a one-year position that ascends into the position of chair the following year. Attached as **Exhibit A** are the statements from the two candidates for NASBE Chair-Elect, Janet A. Cannon of the Utah State Board of Education and Ron McNinch of the Territory of Guam Education Board.

I have a long history of service within the organization and feel that as a State Board member, my state and I have benefited greatly from being a part of this organization whose unique purpose is to support and benefit State Boards of Education throughout the US states and territories.

I currently serve on NASBE's Board of Directors as Western Area Director. During my tenure, I have tried to reach out and engage board members in the West, by educating them about the benefits NASBE offers to State Boards and providing them with opportunities for participation in the organization. I was first elected to a two year term as a new member representative. I then was elected to a three year term as a western director during the transition to a smaller board in 2019.
