negotiate furloughs

## I. BACKGROUND

On June 18, 2020, the Board of Education ("Board") adopted a resolution providing the Department of Education with big picture guidance on preparing to reopen schools amid the COVID-19 global pandemic ("Reopening Resolution"). Among other things, the Reopening Resolution authorized Board Member Kaimana Barcarse to represent the Board in mid-term bargaining with the Hawaii State Teachers Association ("HSTA"), and it authorized Board Member Dwight Takeno to

represent the Board in mid-term bargaining with the Hawaii Government Employees Association ("HGEA").<sup>3</sup>

Subsequently, a conflict arose that prevented Board Member Takeno from continuing as the Board's representative. Consequently, the Board authorized another Board Member to represent the Board in mid-term bargaining with HGEA. At its October 1, 2020 special meeting, the Board authorized Board Member Margaret Cox to represent the Board in mid-term bargaining with HGEA and to identify and negotiate any changes, exemptions, or modifications to the current Unit 6 collective bargaining agreement as deemed necessary to meet the policies, directives, and objectives of the Board's July 18, 2020 Reopening Resolution.

## II. DISCUSSION

The State of Hawaii is facing significant revenue shortages, and Governor David Ige anticipates furloughs of state employees will be necessary to balance the State's budget. The State needs to negotiate such furloughs with the labor unions who represent any affected state employees. Pursuant to Section 89-6, Hawaii Revised Statutes ("HRS"),<sup>4</sup> the Board is part of the public employer group, along with the Governor and Superintendent, for Bargaining Unit 5,<sup>5</sup> which HSTA represents, and Bargaining Unit 6,<sup>6</sup> which HGEA represents.

## **III. RECOMMENDATION**

Based on the forgoing, I am recommending that the Board expand Board Members Barcarse and Cox's mid-term bargaining authority to allow them to negotiate furloughs.

"BE IT FURTHER RESOLVED that the Board authorizes Board Member Dwight Takeno to represent the Board in mid-term bargaining with the Hawaii Government Employees Association and to identify and negotiate any changes, exemptions, or modifications to the current Unit 6 collective bargaining agreement as deemed necessary to meet the policies, directives, and objectives of this resolution[.]"
