SUBJECT: Approval of Waimea High School's School Community Council (SCC) Exception  
Regarding its Revised Attendance Procedures

1. **RECOMMENDATION**

That the Board of Education (BOE) approve Waimea High School's SCC Exception Request allowing the school to implement revised attendance procedures for the 2012-2013 school year.

Note: By agreement with HSTA, the school's attendance procedures are "incorporated by reference" to the BU 05 Collective Bargaining Agreement. BOE approval of exceptions to the BU05 Collective Bargaining Agreement must include all stipulations agreed upon by its two (2) committee members to the SCC Exception Review Committee. The status quo shall remain should the BOE not agree with its committee members' recommendation(s).

2. **RECOMMENDED EFFECTIVE DATE**

Upon approval by the BOE.

3. **RECOMMENDED COMPLIANCE DATE**

Not applicable.

4. **DISCUSSION**

a. **Conditions leading to the recommendation**

Section 302A-1124 to 1127, Hawaii Revised Statutes (HRS), authorizes schools to request waivers from existing state agency rules, policies, regulations, and procedures as well as exceptions to collective bargaining agreements as negotiated in accordance with current collective bargaining agreements and the provisions of Chapter 89, HRS.

b. Previous action of the Board on the same or similar matter

Similar exceptions were approved for Hilo High School, Honokaa High and Intermediate School, Kahuku High and Intermediate School, Kailua High School, Kaiser High School, Kalaheo High School, Kalani High School, Kauai High School, Kohala High School, Maui High School, Mililani High School, Waiakea High School, Waialua High School, Waianae High School, Waimea High School and Waipahu High School.

d. Arguments in support of the recommendation

The attendance procedures requested by Waimea High School for 2012-2013 school will allow the school to:

- Change the definition of "Absent" to read: "Absent means the student is not physically present in school for at least half the school day or" absent from each class after fifteen (15) minutes from the ending of the tardy bell, except if the student is on an authorized school activity.
- Institute a consequence for students who do not meet the ninety-five percent (95%) attendance benchmarks, meaning having less than ten (10) unexcused absences for the year as a means to stress the importance of being in school for learning to take place.
- Not allow students to participate in any co-curricular activities for the rest of the year once they have ten (10) or more unexcused absences.
- Utilize an appeal process to the principal when necessary for final decision to be made.

e. Arguments against the recommendation

The following concerns/cautions were expressed by the Department of the Attorney General when this request was initially approved and are reiterated as cautions for the implementation of these types of requests:

- If this proposed change is applied to all students, the school must ensure that these procedures do not conflict with the Individuals with Disabilities Education Act (IDEA) as it is applied to Special Education (SPED) students. For example, if

applied to a SPED student, it must be a part of the student's Individualized Education Program (IEP). (IDEA, 20 USC, Section 1401).

- Section 504 of the Rehabilitation Act of 1973, (20 USC, Section 794), says that for the persons who require special accommodations because of some disability, "reasonable accommodations" must be made.
- Section 302A-1132, HRS, Attendance, compulsory; exceptions, states that "all children...shall attend either a public or private school...and any parent, guardian...shall send the child to some such school." The statute also delineates when such attendance shall not be compulsory. "The law does not say that schools may determine other exceptions to compulsory attendance such as allowing a number of unquestioned absentee days." Technically, any unexcused absence is a violation of the compulsory education law.
- Goss vs. Lopez, Supreme Court decision (419 US 595-1975) states that a student cannot be excluded from school for more than ten (10) days without a formal due process hearing. If a student stops attending classes because the school has already declared that he/she will not pass or if a teacher remarks to the student that attending classes is no longer necessary because he/she will fail anyway, this Supreme Court decision would impact that kind of action.
- The attendance procedures (especially Saturday School) perpetuate the mindset that learning is measured by the amount of time spent in class, rather than performance and/or application of what is learned.
- Department staff also expressed concerns that this kind of exception is philosophically contrary to Board policy/directions and to some extent contrary to what the Department has been trying to accomplish with the emphasis on standards-based reform. Data may not show increased learning, i.e., emphasis is being put on "credit for just showing up."

f. Findings and conclusions of the Board committee

The BU 05 Committee on SCC Exception Review agreed to this exception on May 8, 2012.

BOE Attendance Policy 4145 – The Department of Education shall establish procedures for the admission and attendance of students in the public schools of Hawaii in accordance with laws, rules, policies and administrative regulations.

Revised DOE Attendance Policy September 2008 –

Definition of Absent – Means that the student is not physically present in school or in a scheduled class for at least half of the school day or class period except if the student is on an authorized school activity.

- B. Describe 1) the desired change, and 2) what the school hopes to accomplish as it relates to improving student learning and increasing student achievement. Include specific quantitative, qualitative and longitudinal data to support the need for the request.

1. Waimea High School would like to change the definition for our purpose to read "Absent means the student is not physically present in school for at least half of the school day or "absent from each class after 15 minutes from the ending of the tardy bell except if the student is on an authorized school activity.

2. Waimea High School also attaches a consequence for students who do not meet the 95% attendance benchmark, meaning having less than 10 unexcused absences for the year, as a means to stress the importance of being in school for learning to take place. Students are not allowed to participate in any co-curricular activities for the rest of the year once they have 10 or more unexcused absences. There is an appeal process to the Principal, who makes the final decision.

- C. If a renewal, describe and evaluate the outcomes of the requested change. Explain what was achieved and the impact on student learning. (Include specific quantitative and/or qualitative data.)

Waimea High School is, presently, on a 79 minute block schedule. A student could miss up to 39.5 minutes of the class period before being marked absent if we adhere to the DOE policy. The faculty voted on implementing 15 minutes as attendance is taken within that time and the majority of direct instruction is presented at the beginning of class. Teachers feel that the DOE policy is too lenient and that some students will deliberately miss half of the class knowing it would only be counted as a tardy and not as an absence. Missing so much information will lead to probable failure and possibly, more attendance issues. With the present 15 minute policy, the majority of the students are getting to class on time. According to our attendance records and teacher reports, students who are tardy, report to class between 1 to 5 minutes of the tardy bell ringing, still within a reasonable time to be involved. Since SY 2001-2002 Waimea High has been below the DOE's 95% average daily attendance benchmark averaging just over 91%, but the data that is important to us is that more than 95% of our students are in class on time and we feel it is because students are aware that they will be marked absent if they do not get to class within 15 minutes of the tardy bell. The faculty understands that implementing the DOE's policy would decrease our daily absentee rate and increase our daily attendance rate because students could not be reported as absent until half of the period is over but, they would rather only allow 15 minutes to send the message that being in class on time is very important. Although tardies are a concern, teachers feel that the present policy holds the students accountable for learning from bell to bell.

The policy to withhold privileges from students when they reach 10 unexcused absences dovetails with the 15 minute absentee policy in stressing to parents and students the importance of attending school. Our attendance records provide accurate account of notes that are turned in and whether they have been designated excused or unexcused according to the criteria stated in our policy. Daily calls are generated to parents when a student misses one or more classes. A letter is sent to parents when their child has received 5 unexcused absences with the attendance policy to alert them. A second letter is sent home when the student reaches the 10 unexcused absences informing them that co-curricular privileges have been suspended for the school year. An appeal notice is also attached. Attendance records indicate that students and parents are very aware of the attendance policy and make effort to send notes to that attendance clerk. The policy states clearly what constitutes an excused or unexcused absences and parents/students are informed whether the note is accepted as excused. This has made a difference because students are more conscientious to bring the note so they can obtain the make up work from teachers.

Rationale:

Rationale: Our average daily attendance rate has remained fairly constant since SY 2001-2002, averaging at 91%. Within the past two years we have seen a slight increase in our attendance average. We attribute a major portion of it to the fact that we are using 15 minutes as the cut off for absences as opposed to the "half a class period" definition. We feel using the DOE's definition would improve our daily average attendance rate drastically, but it would increase our tardy rates and cause tardy students to miss more time in class, therefore missing more information which may lead to possible failure or other attendance issues. We would rather decrease the time a student has of missing valuable information by enforcing a stricter policy. Thus only allowing 15 minutes before a student is marked as absent. Our tardies still remain a problem but the time missed is minimal compared to half of a period.

Even though students are marked absent after 15 minutes, they are still allowed in class to participate in the daily lesson and makeup what was missed in the first 15 minutes or so. If a student is absent for the day they are allowed to make up work per the DOE's attendance policy. Teachers are allowed 24 hours from the time of request to provide it to our counselors' EA where parents and/or students may pick it up. Students are given make up work from Day 1 of their absences.

## Waimea High School's Attendance Policy Information for Parents/Guardians and Students SY 2012 - 2013

Upon enrollment, a student is expected to attend school regularly, to attend all classes and to arrive at school and in the classroom on time. He/she should understand that by law, he/she is required to be in attendance. Excessive absences easily lead to failure in one or more courses. **Since the school year 1996-97, a student must pass all required courses, maintain a 2.0 grade point average, and meet the attendance benchmark of 95% (not more than 9 days of unexcused absences) in order to participate in co-curricular activities. Seniors failing to meet the attendance benchmark of 95% may be denied the privilege of participating in commencement exercises.**

1. The student will adhere to attendance policies and procedures.
2. The student must have his/her parent/guardian call the school (338-6810 ext 110) on the day of his/her absence to report the absence and the student must provide the attendance office with a **written note** from his/her parent/guardian explaining the absence. ***If a student fails to bring a note from home within three (3) school days of return, the absence will automatically become "UNEXCUSED"***. The school, according to Rule 4160.1, will determine excused or unexcused absences.

### EXCUSED ABSENCE

Inclement weather; Illness / Serious injury  
Medical/dental/scholarship appointments, which cannot be scheduled for after school, Saturday, or holidays  
Court appointments; Death in the family; College Visitations  
Family Emergency / urgent medical assistance for immediate family members; Emergency teen parent child care  
Administrative approved job interviews related to school activities (School to Work Program, Modified Schedule, etc)

### UNEXCUSED ABSENCE

*Family Vacation / Trip; Parent request without explanation*  
*Personal business reasons / personal family business reasons*  
*Working on school assignment / project; Driver's Permit / Road Test*

3. Request for an Off-Campus pass must be made in writing and submitted 24 hours prior to leaving during non-instructional time to the Front Office clerk. Request for an Off-Campus pass for medical reasons (doctor/dental appointment) must be made in writing and submitted 24 hours prior to leaving during non-instructional time to the Health Aide. Requests signed by the parent/guardian, must include the **student's name, contact number (home or work), reason for the off-campus pass, destination, and the time the student is to be dismissed**. ALL OFF-CAMPUS PASSES should have the teacher's initials prior to leaving campus. Validation for verification will be requested in some instances. The OFF-CAMPUS PASS should be retained by the student while off campus and placed in the Attendance box upon return to school. Student's leaving campus during instructional time without permission and without an off-campus pass from either the front office or health room will not have their absence excused.

### EXCUSED OFF CAMPUS PASS

Illness; Court appointments; Death in the immediate family  
Medical/dental/scholarship appointments, which cannot be scheduled for after school, Saturday, or holidays

### TARDIES

The School Community Council (SSC) unanimously voted to support Waimea High School's tardy policy for the school year 2012-2013. This policy is pending approval by Superintendent Matayoshi to help us to reach our attendance goal of having 95% of our students present in class and on time. The school policy states: "a student will be considered absent from each class after 15 minutes from the ending of the tardy bell except if the student is on an authorized school activity". We feel it is because students are aware that they will be marked absent if they do not get to class within 15 minutes of the tardy bell will help students to see the importance of being in school and in the classroom on time. Students who are late to school or class without a valid reason will be assigned after school detention in our detention room on "A" block days from 2:10pm to 3pm.

4. The legitimately absent student has the responsibility to request and complete any make-up work within a reasonable length of time. (Reasonable length of time is to be determined at the discretion of the teacher).
5. Mid Quarter Progress Report/Attendance Report and Quarterly Report Card/Attendance Report will be mailed home. UNEXCUSED ABSENCES with extenuating circumstances that have not been excused due to no follow-up note within the three day return to school will need a note from a doctor and presented to the principal for approval within a reasonable time.

It is important that parents / guardians work with school officials to correct attendance problems. If continuous efforts fail to reduce chronic absenteeism, Family Court will be asked to intercede.

1. Parents/guardians should be familiar with attendance policies and procedures
2. ***Parents/guardians are to notify the Attendance Office of legitimate absences by written note\* and a phone call explaining the absence (student phone call will also be recorded as an unexcused absence). \*A note must be submitted to the Attendance Office upon return to school within three (3) days. The note must include the legal name of the student, phone number, reason and duration of the absence and parent/guardian signature. (The Attendance Office personnel have the right to refuse any note that is missing information or is illegibly written).*** The school, according to Rule 4160.1, will determine excused or unexcused absences.
3. **An absence without a written note will be regarded as an UNEXCUSED ABSENCE.**
4. Parents will be notified about chronic absences and daily tardiness. Disciplinary action may/will be administered by the school.
