SUBJECT: Update on Department of Education's ("Department") Operating Budget

Appropriations for Fiscal Biennium 2023-2025

1. EXECUTIVE SUMMARY

- House Bill 300, Conference Draft 1 (HB 300 CD1), the State budget bill, was passed by the Hawaii State Legislature on May 4, 2023, the last day of the 2023 Legislative Session.
- HB 300 CD1 awaits the Governor's action; the deadline is July 11, 2023.
- HB 300 CD1 provides less general fund support for the Hawaii State Department of Education (Department) than was requested by the Governor via the Executive Budget for Fiscal Year (FY) 2023-2024 and FY 2024-2025 and by the Department as approved by the Hawaii State Board of Education (Board).
- HB 300 CD1, Section 5 includes \$200 million in discretionary funding for the Governor that
 can be transferred to State departments and agencies for government operations. The
 Department has requested a portion of the \$200 million to bridge the gap between what
 was requested in the Executive Budget and what was appropriated to the Department in
 HB 300 CD1.
- Indications thus far from the State's Executive Administration have been positive and the Department is awaiting a formal decision by the Governor.
- The Department is very concerned about securing sustained funding for FY 2024-2025 and is already preparing for the FY 2024-2025 Supplemental Budget.

2. <u>DESCRIPTION</u>

Status update for the Department's Fiscal Biennium (FB) 2023-2025 operating budget.

3. UPDATE SUMMARY

The 2023 Legislative Session ended on Thursday, May 4, 2023. On the final day, the Legislature passed the State budget bill, HB 300 CD1, with the House of Representatives (House) passing it with 35 ayes, 6 ayes with reservations, 8 noes, and 2 excused and the Senate passing it with 25 ayes and 0 noes. During floor debate on HB 300 CD1, there were concerns raised by several members of the House regarding funding for the Department. In the Senate, disappointment was expressed by the Ways and Means Committee Chair that various K-12 education initiatives did not make it through the Conference Committee negotiations.

The <u>Legislative Budget Worksheets</u> that contain additional details on the adjustments made to the budget by HB 300 CD1 were posted to the Legislature's website on Monday, May 15, 2023. The worksheets outline the appropriations made to the Department for FY 2023-2024 and FY 2024-2025.

Part III, Section 5, of the HB 300 CD1 includes a provision that provides the Governor up to \$200 million in discretionary funding in FY 2023-2024. The funding can be transferred to State agencies for government operations. The Department has requested funding from this \$200 million, a one-time general fund appropriation for FY 2023-2024, and initial indications for consideration from the Governor and Department of Budget and Finance (B&F) have been positive.

HB 300 CD1: General Fund Appropriations Compared to Governor's Budget

HB 300 CD1 appropriates fewer general funds than was requested by the Governor via the Executive Budget, including the Governor's Messages that amended the initial submittal.

At the aggregate level by EDN (excluding EDN 450 – School Facilities Authority – and EDN 700 – Executive Office of Early Learning), HB 300 CD1 provides \$57,073,237 less in general funds for FY 2023-2024 and \$109,683,838 less in general funds for FY 2024-2025. Attachment A provides a summary of the general fund appropriations by EDN in HB 300 CD1.

HB 300 CD1 established appropriation levels for non-general funds to accommodate anticipated expenditure levels that are commensurate with anticipated available revenues. Attachment B provides a summary of the non-general fund (i.e., federal, special, revolving, trust) appropriations in HB 300 CD1.

HB 300 CD1: General Fund Appropriations Compared to Board-Approved Requests

HB 300 CD1 did not provide all Department requests approved by the Board on October 20, 2022 and on December 15, 2022.

- Of the \$186,881,176 in requests for general funds approved by the Board for FY 2023-2024, \$88,720,141 was included in HB 300 CD1. This amounts to \$98,161,035 in requests not included in the general fund budget for FY 2023-2024.
- Of the \$213,541,202 in requests for general funds approved by the Board for FY 2024-2025, \$50,044,527 was included in HB 300 CD1. This amounts to \$163,469,675 in requests not included in the general fund budget for FY 2024-2025.

Attachment C provides a line-by-line listing of the Board-approved requests included (funded) in HB 300 CD1.

Attachment D provides a line-by-line listing of the Board-approved requests not included (not funded) in HB 300 CD1.

HB 300 CD1 is currently awaiting the Governor's signature. The Governor has until June 26, 2023 to announce his intent to veto or line-item veto the bill. He will then have until July 11, 2023 to either veto the bill and return it to the Legislature or choose to sign, line-item veto, or not sign the bill, all of which would allow the bill to become law and be assigned an Act number.

Process After Bill is Enacted into Law

Once the budget bill becomes law, the State departments and agencies must adhere to the budget process governed by Hawaii Revised Statute Chapter 37 and overseen by B&F before they are able to expend appropriated funds. In summary:

- a. B&F, through the Governor, issues the budget execution instructions and policies for the fiscal year.
- b. The instructions and policies indicate the level of funding (allocation) for the Department, including additional collective bargaining funding appropriated by the Legislature in bills outside of HB 300 CD1 and any restrictions as applicable. Note that no restrictions are anticipated at this time.
- c. The Department must submit operational expenditure plans and requests for allotment for B&F's review and approval. Upon approval, the Department of Accounting and General Services enters approved amounts into the State's accounting system.
- d. After the allotment is processed, funds are available to the Department to expend via the Department's financial system.

The Road Ahead for FY 2023-2024

The level of general funds for the Department provided by HB 300 CD1 has been recognized publicly as less than ideal. However, for FY 2023-2024, there is a mechanism in HB 300 CD1 that may help the Department bridge some of the gap between what the Department requested and what was provided in HB 300 CD1.

Part III, Section 5, of the budget bill includes a provision that provides the Governor up to \$200 million in discretionary funding in FY 2023-2024. The funding can be transferred to State agencies for government operations.

The Department has requested funding from this \$200 million, a one-time general fund appropriation for FY 2023-2024, and is working with the State's Executive Administration to bolster funding levels to get closer to the amounts requested by the Governor for FY 2023-2024. Any additional funds the Department may receive would be applied towards funding items included in the Department's Board-approved biennium request. Given the limited amount of discretionary funds available and many competing needs, we do not anticipate the Governor will be able to close the FY 2023-2024 funding gap entirely.

Some strategies the Department may consider to work within available funding include:

- a. Delaying implementation of certain initiatives;
- b. Scaling back certain services or programs;
- c. Securing alternative sources of funding, including federal funds; and
- d. Requesting emergency appropriations in the 2024 Legislative Session, if needed.

Specifics will be discussed with Department leadership for each office to maximize the use of limited funds.

In HB 300 CD1, the Department did receive additional funding for items not approved by the Board to implement legislative initiatives. Attachment E provides a listing of these additions.

At this juncture, the Department awaits the final decision from the Governor on the budget bill and on the funds we may receive from the \$200 million in discretionary funds.

Looking Ahead to the FY 2024-2025 Supplemental Budget

The Department anticipates facing considerable funding challenges in FY 2024-2025 to sustain ongoing work, which will need to be addressed in the FY 2024-2025 Supplemental Budget.

As detailed in Attachment D, there is about \$163.4 million in Board-approved requests in FY 2024-2025 that were not fulfilled in HB 300 CD1. The Department will be reviewing these requests as we prepare for the FY 2024-2025 Supplemental Budget request.
