### 4. <u>DISCUSSION</u>

a. Conditions leading to the recommendation:

Section 302A-1124 to 1127, HRS, authorizes schools to request waivers from existing state agency rules, policies, regulations, and procedures as well as exceptions to collective bargaining agreements as negotiated in accordance with current collective bargaining agreements and the provisions of Chapter 89, HRS.

The number (203) of Waiver/Exception requests for School Year 2022-2023 is over three times more than last year. The Department believes that the three major factors contributing to this increase are:

- 1) Greater school-level understanding of and compliance with the SCC Waiver/Exception process outlined in Board Policy 500-20;
- 2) A clearer understanding of the waivers that affect a provision in HSTA's CBA; and
- 3) The widespread need for professional development and teacher collaboration time which has been exacerbated by the loss of 21 hours of embedded professional development in the current HSTA CBA and the shortage of teacher substitutes.
- b. Previous action of the Board on the same or similar matter:

On June 17, 2021, the Board unanimously approved a total of 59 SCC Waiver requests. The Board approved 56 requests to waive the number of student instructional days required in Section 302A-251, HRS, pursuant to Board Policy 106-5 Student Instructional Hours and School Year Requirements Policy and Waiver Process and three (3) requests for exceptions to provisions in the HSTA CBA.

- d. Arguments in support of the recommendation:

Schools throughout the state are struggling with the effects the COVID-19 pandemic has had on students academically, socially and emotionally. To address students' learning loss and social-emotional needs and to strengthen instructional practices, schools are requesting additional days to train teachers and staff on school-level and/or complex-wide initiatives to implement new curriculum in areas such as Computer Science, Language Arts, Math, Science, Social-Emotional Learning, Project-Based Learning, and Nā Hopena A'o (HĀ) or to vertically align K-12 Career and Technical Education/Career Academy efforts.

Schools requesting waiver days for professional development have stated that such training is integral to the schools' Academic Plan and is recommended through the schools' comprehensive needs assessment or WASC accreditation process. Schools have also stated that teachers and staff need extended periods of time to analyze student data, create formative assessments, meet with Response to Intervention teams, and develop Tier 1 strategies aligned with the Hawaii Multi-Tiered Systems of Support.

Schools are also requesting flexibility in how they conduct parent teacher conferences, Kindergarten and new student orientation, and in setting an earlier graduation date.

Waiver requests have been reviewed and approved by school administrators, HSTA members, SCCs and respective Complex Area Superintendents and thoroughly vetted by the SCC Exception Review Committee.

e. Arguments against the recommendation:

Of the 203 SCC Waiver/Exception requests, 93% (189) will result in a decrease in student instructional hours for all students or for students in particular grade levels. Less student instructional days may make it difficult for students, especially vulnerable learners, to make gains in their academic achievement.

f. Findings and conclusions of the Board committee:

The SCC Exception Review Committee, composed of the Board designees, and representatives from the HSTA BU 05 and the Hawaii Government Employees Association (HGEA) BU 06, has agreed to this request.

**§302A-251 School year; student hours.** (a) Notwithstanding any other law to the contrary, beginning with the 2011-2013 school years, all public schools, excluding charter schools and multi-track public schools, shall implement a school year of one hundred eighty days, excluding professional development days and other non-instructional days negotiated pursuant to chapter 89.

- (b) Notwithstanding any other law to the contrary:
- (1) For the 2011-2012 school year, fifty per cent of all public elementary schools in the State, excluding charter schools and multi-track public schools, shall implement a school year that includes nine hundred fifteen student hours; and
- (2) Beginning with the 2012-2013 school year, all public elementary schools in the State, excluding charter schools and multi-track public schools, shall implement a school year that includes nine hundred fifteen student hours.

(c) Notwithstanding any other law to the contrary, for the 2015-2016 school year, all public secondary schools, excluding charter schools and multi-track public schools, shall implement a school year that includes nine hundred ninety student hours.

(d) Notwithstanding any other law to the contrary, beginning with the 2016-2017 school year, all public schools, excluding charter schools and multi-track public schools, shall implement a school year of one hundred eighty days, excluding professional development days and other non-instructional days negotiated pursuant to chapter 89, that shall include one thousand eighty student hours for both elementary and secondary school grades.

(e) The board, in its discretion, may grant a waiver to any individual school subject to the student hours or one hundred eighty day school year requirements in this section. The board shall adopt policies and procedures to grant a waiver under this subsection.

(f) For purposes of this section, "student hours" shall be inclusive of the full school day in alignment with the State's general learner outcomes.

(g) The department of education, with the board of education and office of the governor, and in consultation with representatives of the affected collective bargaining units, shall submit to the legislature, no later than twenty days prior to the convening of the regular sessions of 2013, 2014, 2015, and 2016, a report on its progress and efforts to meet the requirements of subsections (a), (b), (c), and (d). ## POLICY 101-12

## ACADEMIC REQUIREMENTS FOR PARTICIPATION IN CO-CURRICULAR ACTIVITIES

Students participating in co-curricular activities must have at least an overall 2.0 grade point average ("GPA") and be passing in courses required for graduation. "Participating," as used in this policy, does not include participation in rehearsals, practices, or tryouts. Activities which are essential and integral to any particular course are not affected by the policy.

The Department of Education shall establish guidelines to implement this policy.

## POLICY 102-15

## HIGH SCHOOL GRADUATION REQUIREMENTS AND COMMENCEMENT

A. Requirements for High School Graduation. The purpose of high school graduation requirements is to establish rigorous standards of learning that will enable all public school students to meet the vision of a Hawaii public school graduate. All Hawaii public school graduates will:

- Realize their individual goals and aspirations;
- Possess the attitudes, knowledge, and skills necessary to contribute positively and compete in a global society;
- Exercise the rights and responsibilities of citizenship; and
- Pursue post-secondary education and/or careers.

Students who demonstrate proficiency in the State Standards and General Learner Outcomes in the required courses or proficiency based equivalents shall receive a Hawaii High School Diploma. Proficiency shall be determined in accordance with established Department of Education procedures.

The minimum course and credit requirements to receive a high school graduation diploma are:

Mathematics**	3.0 credits including Algebra 1 (1 credit), Geometry (1 credit) and 1 credit of common core aligned math elective or proficiency based equivalent
Science	3.0 credits including Biology and 2 credits of standards based science electives or proficiency based equivalents

Fine Arts	
Career and Technical Education	
Physical Education	1.0 credit or proficiency based equivalent
Health	0.5 credit or proficiency based equivalent

A Hawaii High School Diploma shall be issued to students who meet the course and credit requirements.

High school diplomas may be granted to 16-year-olds and 17-year-olds who have qualified for graduation through adult schools.

\*DOE will establish a process for developing and approving all proficiency-based equivalents similar to the process followed for all other new Authorized Courses and Code Numbers.

\*\* A series of courses that satisfy the minimum learning expectations for all students as delineated in the College and Career Readiness Standards that are encompassed by the Common Core State Standards ("CCSS") for Mathematics.

The graduation requirement for a high school diploma for students with disabilities shall be the same as students without disabilities.

B. Commencement Exercises. Commencement exercises may be scheduled any time after the last day of school for seniors. The last day of school for seniors shall be set by the Department of Education. Students shall be permitted to participate in commencement exercises if they: (1) meet the requirements for a diploma or a certificate; (2) have fulfilled their financial obligations; and (3) meet other conditions, established by the Department of Education, which meet the standards of clarity, reasonableness, and justifiability.

## POLICY 500-26

## NEW STUDENT ORIENTATION

Secondary schools may establish a one-day orientation program on the first school instructional day which is attended exclusively by students in the incoming grade provided that:

- 1. The decision is approved by the school community council;
- 2. All staff report for a full day of work; and
- 3. All grade levels report for a full day of instruction on the succeeding day.

Orientation programs provided under this policy shall constitute a waiver to the student hours required pursuant to section 302A-251, Hawaii Revised Statutes.

**Rationale:** The transition to secondary school may be difficult and may cause stress and anxiety for both parents and students. School data indicate that students in the incoming grade level experience the most difficulty in school adjustment. A one-day orientation program on the first school instructional day attended exclusively by students in the incoming grade may be beneficial to the entire school community.

# SP 4510.3 Released Time for Conferences to Report Student Progress

Released time for conferences to report student progress are subject to the following regulations:

- 1. That dismissal of classes by limited to:
  - a. The hour immediately before the end of the student day;
  - b. Ten days in any one year.
- 2. That appropriate means be determined by the principal that a majority of the parents approved the dismissal of classes for the purpose of holding conferences to report student progress.
- 3. That the plans for released time be made known to the district superintendent and approved in advance of the scheduled dates for dismissing classes.
- 4. That specific provisions be made for the evaluation of the released time project, including problems encountered.
- 5. That a report be made to the district superintendent on the results and evaluation of the first released time project in any school.
- 6. That provisions be made to supervise students in school when dismissal prior to the regular time creates undue hardship on the parents.
- 7. That students not be penalized when the parents are unable or unwilling to participate in early dismissal provisions of conferences.

# SP 2404: Pre-Kindergarten and Kindergarten

## 1. Purpose

To provide kindergarten programs to all children who meet entrance requirements and pre-kindergarten education to children, ages three to five, who are participating in DOE preschool programs.

## 2. Effective

Immediately. This SP supersedes Regulation 2404.1.

## 3. Applies to

All elementary schools.

## 4. Background

Hawaii Revised Statues (HRS), Section 302A-1132 establishes compulsory school attendance requirements for Hawaii's children (see Reference (c), HRS 303A-1132. Act, 178 Hawaii State Legislature Session, 2012 changed the age criteria for kindergarten entry. Additionally, the Department of Education (DOE) has always provided prekindergarten education for children age three to five who qualify for services under the provisions of the Individual with Disabilities Act (IDEA). In 2014, pre-kindergarten programs were implemented at DOE pilot schools for students who did not meet the kindergarten age requirement. In addition to the age requirement, enrollment in this program is dependent upon family income and limited to 20 students per class.

The Board of Education (BOE), recognizing the positive impact kindergarten attendance has in promoting school readiness, supports these programs via BOE Policy 2404.

## 5. <u>Guidelines</u>

<u>Enrollment of Kindergarten Students:</u> All elementary schools should offer qualified children access to a kindergarten program, following entry requirements established by Act-178 and HRS 304A-1132.

<u>Enrollment Age of Kindergarten Students:</u> As required by HRS 302A-1132, elementary schools need to adhere to age requirements when registering students. Based on Act 76 of 2004, parents of children five years of age on or before July 31 of the school year shall enroll the child in kindergarten.

Individual school websites may also contain information about their Kindergarten programs. <u>Transition/Orientation</u>: Elementary schools need to have a transition process in place to help families and staff ensure that the child's transition from home to pre-kindergarten (if applicable) or kindergarten is as smooth as possible. Whenever feasible, this transition process should include orientation for parents and new students. While planning for this process, schools must still meet the minimum required hours of "student time" per school year as required in Hawaii Revised Statutes 302A-251. This statute requires elementary schools to meet 915 hours of "student time: in school year 2015-2016; 1080 hours in school years 2016 – 2017 and 2017-2018; and 1146 hours in 2018 – 2019. Schools should ensure that a) the orientation does not exceed five school days; b) parents/legal guardians are informed of the purpose of the orientation and the critical role they play in the education of their child; and c) parents/legal guardians are provided information about the orientation session's schedule and purpose no later than two weeks prior to the orientation date for their child.

<u>Complex Area Superintendent Responsibility:</u> The Complex Area Superintendent should approve any variation from the transition procedures stated in the section above, especially those related to the orientation schedule.

<u>Developmentally-Appropriate Teaching Strategies:</u> The pre-kindergarten and kindergarten program should be student-centered and provide developmentally appropriate teaching strategies and learning activities (see Reference (b), BOE Policy 2235).

<u>Assessment:</u> Assessment of young children is complex and must adhere to best practice and knowledge of young children. In addition, schools must have a clear purpose and plan for the collection and use of assessment information.

Assessments must a) benefit the children and adults who work with children; b) be used for the purposes for which they are designed; c) provide useful, valid and reliable data; and d) include the developmental domains of young children and multiple tools to gather data.
