IV. B. Committee Action on Department of Education's repair and maintenance priority list in accordance with Board Policy 301-10, Equitable Allocation of Facilities Resources (FIC Strategic Priority 2)

To Chair Uemura and Members of the Finance and Infrastructure:

The Hawaii State Teachers Association has serious questions about Board Policy 301-10, Equitable Allocation of Facilities Resources which enables "HIDOE to complete all facilities projects at our schools with the greatest socioeconomic and academic needs to advance equity (FIC Strategic Priority 2)."

According to the Jacobs study on the DOE statewide facilities mater plan, it states that top priority projects for basic repair and maintenance and overcrowding for DOE schools is 7 billion, yet the legislature's annual appropriation is approximately \$300 million. It will take decades before appropriations meets needs.

In a world where school facilities were funded at or near need then this policy would work. The concern is that if Title 1 schools are prioritized for limited dollars, then non-title 1 school facilities will be in jeopardy of falling under disrepair, because every year they would be the lowest priority.

If legislators also see that schools in their districts may never see CIP, because of this policy they may be less likely to advocate and pass CIP funding.

HSTA would ask that these issues be addressed about this policy before implementation.
