Aloha Board Members,

My name is Sunny Unga, Kahuku resident, and I strongly support my Petition No.20-01 proposing the adoption of a new administrative rule that will ensure that a public meeting be held to obtain and consider the views of the community before the BOE provides official comment regarding project nearby schools or public library.

DOE is frequently asked to provide official comments regarding projects occurring near schools even without its authority over proposed developments. As a well established state government institution, the DOE's decisions carry significance and have strong influence. The DOE has provided numerous comments on these proposed developments near schools up to date and will continue to do so. It is important that the DOE consult affected communities before it supports or makes any official comments on any projects or developments near their school. It is crucial that the DOE's official stance and comments align with its community in order to avoid what happened with the Kahuku Schools and its own community.

The developer for NPM asked the DOE to provide an official comment regarding its project that currently towers over Kahuku Elementary, Intermediate, and High School. In the EIS, the DOE stated that the students will hear the turbines but stated no concerns regarding the project. On the contrary, this NPM wind project lead to a mass arrest of the Kahuku community where majority of the arrests were mothers, grandmothers, and aunties who were extremely concerned regarding the proximity of these turbines to our children's schools and how this would detrimentally impact the health, safety and the learning environment of our keiki. This huge disconnect caused much contention and conflict with the community and the DOE.

Holding a public hearing and getting the affected communities input prior to the DOE making any official comments on these projects near schools would allow the DOE to bridge this gap. It will allow the DOE to become aware of parents concerns and provide an opportunity to address them early on in the process.

In addition, I believe that the DOE could have made a difference in resolving the parents' concerns with its influence and weight as a well established government agency. Had the DOE advocated and stood with its affected students and community in solidarity and expressed grave concerns on how this project would detrimentally impact the health, safety and learning environment of our keiki; I believe it would have been difficult for other decision making agencies, city and state leaders to ignore these concerns and allow these projects to move forward without addressing them. These 568 feet industrial turbines are now towering over Kahuku Elementary, Intermediate, and High school. Have any of you personally come to visit the Kahuku schools to personally witness the tragedy of these turbines right next to our keiki's learning facilities? These are the closest and largest land turbines ever located to a school and residential community in the U.S. We

cannot ignore the detrimental impacts that this close proximity brings to the very students the DOE is to advocate for.

The DOE has a duty to ensure that the students and faculty have a safe learning environment. If projects nearby schools compromises the safety, wellbeing, and its learning environment, the DOE must be able to address this especially prior to making any official comment on EIS's. One of the best ways in finding out these concerns is by talking to the very community that will be impacted by these projects. There would be no issue if there are no community concerns. However, if there are legitimate concerns then the DOE must be willing to support its students and advocate on behalf of them to ensure a healthy and safe learning environment and be expressed in its official comments to EIS's or official statement.

DOE may state that any comments the department provides to state or county agencies or private landowners on proposed developments' are its own views and not the views of the community, and therefore irrelevant. However, we all understand that the community is an essential part of the school and the school is also an essential part of the community especially in rural communities. Oftentimes, the school becomes part of the community's identity as in the case in Kahuku. With this, it is difficult to justify that the DOE's stance has no impact on its community supports it as well. The problem occurs when the school makes an official comment or stance in support of a project while the community opposes. This created much contention with the school and community and our children suffered as a result of that.

Our community went through a traumatic experience during the mass arrest of over 200 community members. Our children saw their grandparents, mothers, fathers, aunties and uncles, cousins get arrested over this project. Many students expressed sadness, anger, and anxiety in school during this time. Rather than helping our students process these complex emotions, the school administration and faculty prohibited teachers from discussing any issues related to the project that was happening literally in their community. In addition, parents of students attempted numerous times through email, letter writing, meetings to raise concerns to no avail feeling ignored and shut down.

We cannot allow another tragedy like this to happen in another community with its own school where they are supposed to feel safe and empowered. More so than ever, we need greater transparency and a better relationship between the school and its community. This rule change can foster a positive relationship with the BOE and community. Please let's learn from what happened in Kahuku and improve how we do things. The first step is by accepting this petition for rule change. Mahalo.

With sadness and disdain, The Lāhui Foundation feels compelled to step forward and use our platform to speak up alongside our community and voice our opinion on the Board of Educations support of the Na Pua Makani project. This contentious project has brought to light many issues that have been ongoing and unresolved in dealings with the community.

The BOE, being a Government institution, is a representative of the welfare and stewardship of children's education with a role to ensure that school districts are responsive to the values, beliefs, and priorities of their community. As government officials and public servants, The BOE is supposed to be in service and employment of the people of Hawai'i, not self-serving for-profit corporations that hold money over our communities' livelihoods and well-being.

The overnight industrialization of the Kahuku school zone is a vast community issue that should have required the Department of Education to exercise much better communication and caution before deciding to support or reject the Na Pua Makani project. Furthermore, the silencing of students, faculty, and staff by the DOE is extremely disheartening. Had the DOE consulted with the community before supporting the Na Pua Makani project, it would have created an opportunity for the community to voice their concerns regarding this project and possibly have avoided traumatic events and the conflict between the schools and the Kahuku community. The BOE's actions speak more of a dictatorship system, where the affected community and employees have no say in the decision-making that directly impacts them. By not consulting with the community, but the damage caused by this will likely have long-standing and far-reaching consequences.

The Sunshine law was designed to protect citizens, provide transparency, and create a dialogue for the community to voice their concerns regarding such projects. The Lāhui Foundation strongly supports Sunny Ungas petition No.20-01 proposing the adoption of a new administrative rule that will ensure public meetings be held to obtain and consider the views of the community before the BOE provides official comment regarding projects nearby schools or public libraries.

We hope that this hearing will allow the board to see how important it is for the DOE to consult with affected communities prior to making any official statement or support for projects near schools.

Aloha, Chair Payne and Members of the Board.

Thank you for this opportunity to share my **support** for amending the process by which the Department of Education responds to comment requests. Any such comment by the DOE should be informed by the interests and will of the impacted community.

The purpose of this proposed amendment would not create an undue burden on DOE or shift responsibility for gathering public comment from proposing entities to DOE. Rather, if asked to comment, the BOE could either decline to provide any comment or make sure it has considered all the facts before commenting.

By asking DOE for comment, the applicant seeks another voice to add to its public outreach, a voice that might not have been heard otherwise. At a minimum, the school principal and school advisory council should be polled. When there is a potential controversy, an opportunity for public input related to school operations or concerns should be welcomed.

In the case of the Na Pua Makani wind project, a controversial development that had been opposed by the Kahuku community for years, the DOE missed an opportunity to accurately comment. Community concerns, particularly about health and wellbeing of students and residents, are school concerns.

Informed decision making requires informed input. DOE would do better by considering the opinion of affected communities before commenting on controversial projects. Surely, the BOE has it within its kuleana to improve its commenting process.
