The Hawai'i Afterschool Alliance (HAA) appreciates the opportunity to provide comments on the proposed agenda item. HAA is a network of individuals and organizations dedicated to advancing sustainable, high-quality afterschool, summer learning, and community school programs that support improved academic, social, emotional, and physical outcomes for children and families across Hawai'i.

The Importance of Summer Learning Programs

Summer learning programs play a critical role in youth development and success. These programs provide opportunities for students to connect with peers and caring adults while accelerating their social, emotional, and academic growth. For many families, summer programs are a lifeline—keeping children safe, healthy, active, and engaged in learning while enabling parents to work.

Without accessible summer learning opportunities, students often experience learning loss, commonly referred to as the "summer slide." Research highlights three critical findings about this phenomenon:

- 1. On average, students' achievement scores decline over summer vacation by approximately one month of school-year learning.
- 2. Declines are sharper in math compared to reading.
- 3. The extent of loss increases at higher grade levels.

The Financial Impact of Increased Fees

When ESSER funds were available from 2020 to 2024, most summer programs were free, benefiting families. However, increasing fees from \$0 to \$260 will impose a significant financial burden on countless families. Without affordable summer programs, many families face limited options, exacerbating existing inequities and restricting opportunities for children to thrive academically, socially, and emotionally.

Recommendations to Ensure Equity

To address these challenges, we propose the following measures:

- 1. Waive summer program fees for students eligible for free and reduced-price school lunches
- 2. Implement a sliding fee scale based on family income.

3. Introduce a sliding fee scale based on the number of children in the family attending summer programs.

These recommendations will help ensure equitable access to summer programs while alleviating financial burdens on families across Hawai'i.

Conclusion

The Hawai'i Afterschool Alliance respectfully urges the committee to incorporate these recommendations. By doing so, we can make a meaningful difference for Hawai'i's families, ensuring that all children—regardless of socioeconomic status—have access to the resources they need to grow, learn, and thrive.

Aloha. As a person who works at a local, grassroots food bank in our state of Hawaii, I am definitely opposed to an increase in school meal prices for our keiki. Our organization serves well over 600 keiki nutritious, after school snacks every day as well as provides weekend food packages to supply 5-7 weekend meals for keiki. Food insecurity is nearly 20% in Hawaii for keiki (Feeding America, 2022) meaning that at least 1 in 5 keiki experience food insecurity as part of their daily lives. We see firsthand how difficult it is for families to afford the basics here in Hawaii-food, housing, utilities, & the overall cost of living continues to increase, forcing many families to make the difficult decision to move to the mainland. Food should be considered a "right", not a "privilege" for the wealthy. In the past, I worked as a school nurse in an inner-city district in California which adopted a "free school meals for all" policy during my time there. At 5 years into this policy, schools consistently reported better attendance by students, more engagement in learning, less illnesses, and better overall health outcomes for students. Isn't this something Hawaii schools should aspire to? Access to healthy, nutritious foods is becoming increasingly out of reach for many of Hawaii's families. The pandemic, current inflation, the already high cost of importing the majority of our food here, as well as reductions in SNAP benefits will just lead more families into food insecurity. As a working class, head of household single mother and climate equity specialist I strongly oppose an increase in school meal fees. The BOE must take into account the stark realities we are increasingly experiencing.

In 29% of households with children, one or more keiki are food insecure. The majority of people in Hawai'i facing food insecurity are keiki, working families and adults living by themselves.

Food insecurity negatively impacts children at every age. Children 3 and younger who experience food insecurity "cannot learn as much, as fast or as well because chronic undernutrition harms their cognitive development during this critical period of rapid brain growth, changing the fundamental neurological architecture of the brain and central nervous system."

At older ages, food insecure children are not only more susceptible to becoming sick, but they can also suffer from other additional physical, developmental and cognitive impairments — resulting in lower academic achievement than that of their peers.

I've heard first hand stories from youth and educators that witnessed and experienced having student meal cards being taken away or meals denied when students ran out of funds on their meal cards.

Choosing to increase school meal fees would create a devastating impact to our keiki's health and wellbeing.

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in **OPPOSITION to increases in fees for student activities, summer school, school meals, and bus transportation.** Our public school students and parents are already struggling to afford to live here. Increasing fees will make barriers to education even higher for those families

We urge you to consider how these fee increases would disproportionately hurt low-income families. Without access to reliable transportation, nutritious meals, and summer learning, our most vulnerable students may end up missing more classes and falling even further behind academically.

When it comes to school meals, the proposed higher prices would put Hawai'i at or above the 90th percentile of school meal prices in the nation, according to the School Nutrition Association's 2024 School Nutrition Trends Survey,¹ which included responses from 1,343 SNA member school districts nationwide.

As you can see in the SNA chart below showing the median prices for school meals in the nation, the proposed increased prices for breakfast to \$2.10 for elementary and middle schools and \$2.20 for high schools, as well as for lunch to \$4.75 for elementary and middle and \$5.00 for high schools, are way out of the norm in comparison with the rest of the nation.

School Meal Prices and Unpaid Meals

School meal prices vary widely across the country. Prices are set by local school districts, usually with school board oversight. The following table lists typical prices for paid meals during the 2023–24 school year. The data was collected in SNA's 2024 School Nutrition Trends Survey, which included responses from 1,343 SNA member school districts nationwide.

With school bus fares, we know that the students who are most likely to need transportation to school are also the most economically vulnerable and the least likely to be able to pay for it. Currently families that qualify for reduced-price school lunch do NOT get free bus passes. And while the income eligibility

limit for reduced-price lunch is about \$66,000 for a family of four,² the "bare-minimum costs of basic necessities" for that same family is nearly \$108,000, according to the *ALICE in Hawai'i* report.³ These families cannot afford higher fees to get their children to school.

For example, a single mom with two children who makes less than \$55,000 a year qualifies for reduced-price school meals, but currently she must pay \$576 per school year for bus passes. The proposed fee increase would raise that cost to \$800. That is a major expense for a family that is already struggling to make ends meet.

In addition, the fact that Hawai'i charges for school bus rides at all puts our district is the minority nationwide. According to *Education Week*, which surveyed a nationally representative sample of school and district leaders, "84 percent said they offer transportation and that no students pay for it."

The pandemic has exacerbated a long-standing problem of chronic absenteeism among DOE students.⁵ Those absences have been concentrated in rural areas and among historically marginalized populations.⁶ Not surprisingly, research shows that access to school bus rides helps vulnerable student populations reduce their absences.⁷

Instead of increasing fees, we urge you to do all you can to make school accessible to students and ensure they have the nutrition and academic support they need to thrive and learn.

Testimony of the Hawai'i Appleseed Center for Law and Economic Justice State of Hawai'i Board of Education Thursday, January 16, 2025

Dear State of Hawai'i Board of Education:

Thank you for the opportunity to submit testimony in opposition to the DOE's proposed increases in fees for school meals, student activities, and summer school tuition.

We understand that the proposal to increase school meal fees is pursuant to <u>HRS 302A-405</u>, which requires students to pay half of the meal program costs. Unfortunately, complying with this statute would raise the cost of school meals for parents more than 80 percent over the next four school years. This would be catastrophic for Hawai'i households, who are already struggling with the cost of living.

A family of four must make less than \$47,000 to qualify for free meals,¹ while Hawai'i's costs of living require that same family to make over \$107,000 to simply survive.² The price increases proposed today would mean the families in this gap—Hawai'i's ALICE population—would be paying nearly \$300 per month just for their children to eat at school. During a time when three out of ten households with children are facing food insecurity, this seems like an ill-considered solution to shore up the DOE's budget.

In lieu of increasing meal fees, we respectfully propose that the Board work with the state legislature this session to strike the clause cited in the proposal. We further propose amending the clause prior, <u>HRS 302A-404</u>, to make one free breakfast and lunch available to all students, and to prohibit denying meals to any student even if they have a negative account balance.

We understand that this is a bold ask and that budget compromises need to be made. However, it is relevant to note that these proposals come just on the heels of a sweeping tax cut that, starting this year, will give \$6,000 in revenue to individuals making over \$1.5 million.³ Instead of asking hardworking public school parents to pay more for meals and other school fees, the Board might consider working with the state legislature to find a more progressive way to pay for school meals, summer school, and student activities.

In closing, please do not increase fees for Hawai'i families. There are a multitude of progressive revenue options the State can explore that would more than cover what is needed to ensure no keiki go hungry during school hours.⁴ Instead of asking public school parents to pay more for meals and other school fees, let's put money back into the pockets of struggling Hawai'i households—money that will ultimately support our local economy. Thank you for your consideration.

As a single mother working full-time, I've also relied on free and reduced lunch for my own children in previous years. I can tell you firsthand, the reality of trying to balance a full-time job, a household, and the costs of raising kids leaves me with little time or money to prepare home lunches.

If school lunch costs were to increase, it would place even more strain on my family. I would struggle to afford not only home lunches but also to find affordable lunch options for my kids outside the school system. I'm sure many families in similar situations would face the same tough choices. And while I understand that you might raise the income limits for qualifying for free or reduced lunch, it seems that such changes would still only benefit certain families, and could result in the only families paying full price being those with a single child—often two-parent households.

This just doesn't make sense. Why would we increase lunch prices when so many families are already struggling to make ends meet, especially in places like Hawaii, where the cost of living is so high? For many of us, it's not just about a meal—it's about making sure our children are fed, have the energy to learn, and aren't going hungry during the school day.

Now, I'm married with four children in school. I work hard and make a decent wage, but I still qualify for reduced-price lunches because the cost of living here in Hawaii is simply overwhelming. Even with my best efforts to manage our finances, it's hard to keep up with the rising costs of everything. Making lunch prices more expensive will only push more families into hardship. We want our kids to succeed, and feeding them properly is one of the most basic, crucial ways we can help them thrive.

Raising lunch prices may seem like a solution, but it feels like it's targeting the wrong people—the families who are already struggling. The better solution would be to keep lunch prices reasonable for all families and ensure that our children continue to have access to healthy, affordable meals. If you focus on making it affordable for everyone, that might help alleviate some of the pressure and ensure no child goes without a meal.

I urge you to reconsider any plans to increase the cost of school lunches. Families like mine depend on these programs to ensure our kids get the nutrition they need to succeed. Please don't make it harder for us to continue providing for our children.

Aloha Chairperson and Members of the Board of Education,

On behalf of Hawai'i Foodbank, I am submitting testimony to express our strong opposition to the Department of Education's proposal to increase the price of school meals.

Hawai'i is already home to one of the highest costs of living in the nation, and this proposal would place an undue financial burden on working families. According to a recent study by the Hawaii Foodbank, 29% of children and 38% of adults in households with children are food insecure. Furthermore, in the most recent ALICE (Asset Limited, Income Constrained, Employed) report, nearly half (46%) of ALICE households struggle with consistent access to food and many do not qualify for free or reduced lunch. Therefore, this proposed increase puts the greatest burden on those who are already unable to afford healthy food for their kids but make too much to gualify for free or reduced lunch. Adding to these concerns, the ALICE study also found that over one-third (37%) of households in Hawai'i have considered leaving the state due to high living and housing costs.

Instead of increasing the cost of school meals and adding an additional burden to our already stretched working families, the DOE should prioritize implementing free school meals for all. Research shows that schools offering free meals see significant academic gains, including improvements in Math and English test scores equivalent to six additional weeks of learning. Such benefits underscore the importance of accessible, nutritious meals for every child in our public schools.

At Hawai'i Foodbank, we see firsthand the impact of food insecurity on our keiki and their families. Through our network of 55 school pantries on O'ahu and Kaua'i, we serve thousands of children and their families who struggle with consistent food access at home. These pantries aim to address the lack of food at home, not in schools. Increasing meal prices would exacerbate this crisis by further burdening families already at their financial limit, many of whom may not qualify for free or reduced-price meals.

This proposal would also lead to increased meal debt, which many families may never be able to repay. Rather than adding to this financial strain, we urge the DOE to take proactive steps to ensure no child in Hawai'i goes hungry at school.

We respectfully ask the Board to reject the proposed meal price increases and instead work toward policies that end hunger for our keiki. Let us come together to ensure that all students in Hawai'i have the nourishment they need to thrive academically and personally.

The DOE itself acknowledges that the proposed increase may impose additional financial burdens on families, particularly those with multiple children. Higher meal prices could lead to decreased student participation and increased student meal debt, potentially impacting both program revenue and student nutrition. While assistance is available for students who qualify for free or reduced-price meals, it is not enough to meet the needs of many families.

According to the Hawai'i Public Schools website, a family of four earning \$47,000 annually does not qualify for free school lunch. Considering the high cost of living here in Hawai'i, \$47,000 is far from sufficient to cover even basic necessities for one person, let alone an entire family.

Aloha members of the Finance and Infrastructure Committee,

The costs of goods and services, especially post-pandemic, have continued to rise. However, funding via student activity fees have not changed to meet this since before 2011. The 2011 memo that is often referred to is not the date when the fees were last increased; rather, it served as a reminder of the cap with which fees and its collection could be done at the school. I am in support of the proposed fee increases by the Department of Education.

We have seen over the years that schools have been able to raise the price of event bids and graduation participation fees since that could be done at the school level. We need your help (and approval) to do the same for student activity fees, which is the sole source of funding for our schools' student activities programs. These funds could help provide leadership training opportunities for student leaders, bring in guest speakers, provide more funding for giveaways or student recognition, hire vendors, and so much more. Just this past year, school bus prices have more than doubled (for example, a bus that was once \$250 now costs \$550 to rent for a group to do a field trip, limiting many clubs and organizations, let alone classes, ability to complement learning and opportunities via off campus excursions). This is just one example of many areas that have seen a cost increase.

The student fees increase can also help smaller schools that bring in even less money through fee collection. It will increase the capacity of our clubs and grade level organizations to provide more for their peers. As a co-advisor at Mililani High School, we exhaust our budget annually through numerous events ranging from school wide assemblies to Homecoming, Award Recognition, Spirit Weeks, Appreciation days, giveaways, and so much more to increase student and staff morale and keep our school community engaged. We've had to work really hard, seek donations at times, and fundraise to stretch our dollars. This fee increase is long overdue in supporting our school programs and the students we serve. It will alleviate some of the cost constraints we face and allow our schools to redirect efforts and focus back on implementation of activities for our students.

This memo includes many other fees in areas that have seen production costs go up (ie. Graduation Cap and Gown, Yearbook, Newspaper, School Lunches). I support the Board of Education increasing these fees to meet the economic realities we are facing.

Testimony in Opposition to Agenda Item IV - Proposed Increases in School Fees

Dear Chairperson Ken Kuraya and Members of the Finance and Infrastructure Committee,

I am writing to strongly oppose the proposed increases in fees for school meals, student activities, and summer school under agenda item IV. These changes would have devastating effects on Hawai'i's keiki and families, particularly those who are already struggling with food insecurity and high living costs.

Personal Experience as an Educator

As a teacher in the Hawai'i Department of Education, I have personally witnessed the effects of hunger on students. Children who come to school without eating often struggle with lethargy, difficulty concentrating, and lower academic performance. Hunger not only impairs their ability to learn but also impacts their emotional and social well-being. For many of my students, the meals provided at school are the only consistent source of nutrition they receive.

Food Insecurity in Hawai'i

Hawai'i is already grappling with alarming rates of food insecurity:

- Nearly **1 in 3 households** were food insecure in 2023, and among households with children, 29% faced food insecurity.
- 6% of households with children reported that a child went an entire day without food due to lack of resources.
- Food insecurity is disproportionately higher among Native Hawaiian and Pacific Islander households, affecting over 40% of these families.

The proposed increases in school meal prices—from \$2.50 to \$4.75 for lunch and \$1.10 to \$2.10 for breakfast over the next few years—will only worsen this crisis.

DOE's Responsibility and Missed Opportunities

The DOE has failed to meet its state-mandated farm-to-school target of 10%, with only 5% of food spending on local ingredients in the last school year. This included counting bottled water as "local food," which does little to nourish students or support Hawai'i farmers. Such systemic failures highlight the urgent need for reform, not additional burdens on families.

Call to Action

Rather than imposing fee increases, I urge the Board to:

- 1. Implement **universal free school meals**, ensuring every child in Hawai'i has access to nutritious food.
- 2. Strengthen and fully commit to **farm-to-school programs**, aligning menus with locally available agricultural products to support both students and farmers.
- 3. Advocate for **alternative funding** through legislative appropriations, public-private partnerships, and federal grants to subsidize summer school and student activities.

Conclusion

As an educator who has dedicated my career to serving Hawai'i's students, I believe it is our collective responsibility to ensure that no child goes hungry or is deprived of opportunities due to financial barriers. The proposed fee increases will disproportionately harm our most vulnerable keiki, undermining their health, education, and future potential.

I respectfully urge the Board to reject these fee increases and instead prioritize equitable, sustainable solutions that invest in the well-being of our keiki and communities.

Hawai'i Public Health Institute (HIPHI)¹ is opposed to agenda item IV, in which the Department of Education (DOE) is proposing to increase fees for a range of student services, including school meals.

All students, regardless of income, are given the opportunity to attend school. Everyone has access to a free public education, it is not just provided to those who can least afford it. The same should be true of the food needed to thrive in the classroom. Food is an absolute necessity for families and students regardless of income.

Under its proposal to the BOE, however, the DOE is seeking to nearly double the price of school meals over the next four school years. School lunches would increase from \$2.50 for elementary and middle school students and \$2.75 for high school students to \$4.75 and \$5.00 by the 2028-2029 school year.

Hurting Those in Need

The proposed changes would drive our prices significantly higher than the national 90th percentile, which currently stands at \$2.50 for breakfast and \$3.75 for lunch. Adopting this would be financially harmful for working families, who already face one of the highest costs of living in the nation. According to a new ALICE (Asset Limited Income Constrained Employed) report, nearly half (46 percent) of ALICE households struggle with consistent food access.²

The report also found that over one-third (37 percent) of households have considered leaving Hawai'i due to high living and housing costs. These statistics reflect the growing economic precarity faced by our state's residents, which gets worse with each passing year.³

Free School Meals for All

Instead of increasing school meal prices for students, the DOE should support free school meals for all, which would expand access to food security for children who may not otherwise be able to eat. Two out of three families that struggle with Hawai'i's cost of living are currently ineligible for free school meals through the federal free lunch program.

Moreover, studies have shown that educational institutions that implement free school meals experience gains in test scores of up to 15 percent.⁴ This significant boost is one of the best and most cost-effective academic interventions our state can make. At roughly one percent of the DOE budget, free school meals would provide a 15:1 return on investment. In addition to helping hungry students get fed, the program would improve the performance of the department itself.

Students need to be fed in order to learn. Nutrition helps overall physical and mental health, and eating allows students to concentrate on school, not on their hungry stomachs. This concept is so well supported that eight states and New York City Schools all provide free meals.⁵ Every child should know that when in school, they will have access to basic food services.

Please reject the proposed school meal fee increases suggested by the DOE. Rather than exacerbating the financial burden of local 'ohana, let's work together to support policies that will empower our keiki to receive the nourishment they need to succeed.

AlohaCare appreciates the opportunity to provide testimony in **opposition** of the proposed **fee increase for school meals**. The Department of Education requests that the Board of Education approve increases to school meal prices beginning in school year 2025-2026.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 70,000 Medicaid and dual-eligible health plan members on all islands. Approximately 37 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

Proper nutrition is vital for keiki growth and development and may reduce the risk of health conditions like anemia, asthma, hyperactivity and anxiety. According to the Hawai'i Foodbank, 1 in 4 keiki in Hawai'i may not know where they will get their next meal, and for more than 81,000 keiki, getting the energy they need to learn and grow can be a daily challenge. 2

Increasing the fees for school meals will increase the financial burden on families and will exacerbate the existing barriers to student nutrition. And while assistance may be available for students who qualify, many students will be denied meals due to inability to pay and their household's income being even slightly over the income requirements to participate in the free or reduced school meal program.

Rather than increase the fees for school meals, AlohaCare urges the Board of Education to consider the implementation of free school meals for all students.

I am an Agriculture Research and Policy Specialist with the County of Hawai'i Department of Research and Development. The County of Hawai'i provides written testimony in **OPPOSITION** to Agenda item IV., to increase school meal fees.

Although section 302A-405, HRS, requires that meal prices cover at least half of the meal production costs, higher meal prices will negatively affect student food access, learning and health outcomes. The County of Hawai'i urges the Department of Education to support universal free school meals, a crucial initiative to address food insecurity, enhance academic performance, and promote equity among students.

Hawai'i County faces the highest rates of food insecurity in the State, with a 2023 study commissioned by the Hawai'i Foodbank finding one in four Hawai'i County households reporting food insecurity. Yet, two out of three struggling families in Hawai'i are ineligible for free school meals due to strict eligibility thresholds. For many children in our communities, the cost of school meals poses a significant barrier to accessing balanced nutrition. Implementing universal free school meals would ensure that all students receive the nourishment they need, regardless of household income, thereby combating hunger and its associated negative impacts on health and well-being.

The Hawai'i County Council has demonstrated its commitment to student school meal access by adopting Resolution No. 42-25, urging the Hawai'i State Legislature to establish a universal free school lunch program for public school students. "They are among a quarter of households in Hawai'i who spent more than their income in 2024.

To make up the difference, people used savings and credit cards and cut expenses. They worked more hours or an extra job. They sold belongings. They borrowed money from family and friends, or banks or other lenders and overdrew their checking accounts."

Board Policy 303-10, Fee for Service, authorizes the Department to set and adjust fees:

"The Department shall determine and assess reasonable fees of public, private, public charter school, and homeschooled students enrolling in Department schools' activities or services when such participation is allowed by law, rule or policy. Fees shall be approved in accordance with procedures established by the Department or overriding law, rule, or policy. A service fee shall be required for access to services and

activities for students not enrolled in Department schools unless prohibited by law, rule, or policy.

It never fails that Public schools continue to expect monetary support to run programs. Public schools are no longer free public education. At the beginning of each year a family with two children in school can expect to pay out of pocket approximately \$100 for each child. Class fees, school supplies, lunch account, teachers requesting fees for supplies, it is endless.

Disregarding that the cost of living is extremely high, parents get hit with fees.

One example: Caps and Gowns went from \$25 to \$125.

My name is Brandon Kinard, and I am writing in opposition to the current proposal to increase school meal prices that parents would have to pay, as outlined in Agenda Item IV of the Board of Education's Finance and Infrastructure Committee Meeting on January 16, 2025.

I acknowledge the Board's authority to make such decisions under Board Policy 303-10. I also recognize the rising costs associated with feeding our children in the school system, with expenditures reaching \$82,018,139.62 during the 2023–24 school year, as reported in the Annual Report on Local Meals and Farm to School Meals (published January 2025). When adjusted for the same product categories, this represents an increase of nearly \$23 million compared to the expenditure reported in the Annual Report on Local Meals (published December 2022).

However, I strongly oppose increasing the financial burden on families. According to the Bureau of Economic Analysis, "States with the highest RPPs were California at 112.6, New Jersey at 108.9, and Hawai'i at 108.6" [1]. Additionally, Hawai'i has been identified by the World Population Review as having the highest cost of living among all U.S. states. Furthermore, an ALICE (Asset Limited, Income Constrained, Employed) report reveals that nearly half (46%) of ALICE households struggle with consistent food access 2, and over one-third (37%) of households have considered leaving Hawai'i due to high living and housing costs [2].

Given Hawai'i's already high cost of living and widespread income insufficiency—where the ALICE report indicates that 84% of annual household incomes fall below the median—this proposal does not appear to be a supportive or equitable decision for our community. It stands to potentially disproportionately impact parents who are already struggling to make ends meet. My aspiration is to support our families by advocating for universal free school meals. This proposed policy stands in direct contrast to that goal.

In conclusion, I urge the committee not to support this policy change. Let us instead work towards solutions that uplift and support Hawai'i's families.
