SUBJECT: Action on revision to School Community Council request for exceptions to collective bargaining agreements, statutory waivers, and waivers of Board policy, previously approved by the Board on April 9, 2026

1. RECOMMENDATION

The Hawai'i State Department of Education (Department) recommends that the Hawai'i State Board of Education (Board) approve the corrections to the list of School Community Council (SCC) Requests for Exceptions to the Hawai'i State Teachers Association (HSTA) Collective Bargaining Agreement (CBA); Waivers of Section 302A-251, Hawai'i Revised Statutes (HRS); Waivers from Board Policy for School Year (SY) 2026-2027; and Waivers from Department Standard Practices (SP) that was approved at the Board's General Business Meeting (GBM) on April 9, 2026, as noted in the attached summary table (Attachment A). Please note the following acronyms in the request summary: professional development (PD), parent-teacher conference (PTC), and planning and collaboration (PC).

2. RECOMMENDED EFFECTIVE DATE

The start of SY 2026-2027, upon Board approval.

3. RECOMMENDED COMPLIANCE DATE

Upon Board approval.

4. DISCUSSION

a. Conditions leading to the recommendation:

The proposed corrections in Attachment A are required to address clerical inaccuracies in the school list approved at the Board's GBM on April 9, 2026. The waiver day request for Hilo Intermediate was incorrectly labeled as 3 days/18 hours, and the PTC request intended for Waiākea Intermediate was incorrectly attributed to Waiākea Elementary. Additionally, upon further review and re-analysis of schools' requests, it was determined that the original request summaries from Konawaena Elementary and Waikoloa Elementary and Middle did not accurately quantify the impact on student hours. And lastly, King Kamehameha III Elementary School submitted their waiver request forms on time; however, due to a misunderstanding of the submission protocol, the materials were not submitted via the required channel, resulting in their exclusion from the April 9, 2026, GBM Board action.

The correct breakdown of each school's total request is outlined below, with proposed corrections for Board approval in bold, and redlined in Attachment A:

- Hilo Intermediate: One (1) request for **one (1) waiver day** (page 4 of Attachment A);
- King Kamehameha III Elementary: **One (1) request for four (4) waiver days** (page 10 of Attachment A);
- Konawaena Elementary: One (1) request for PTC and **one (1) request for two (2) waiver days** (page 11 of Attachment A);
- Waiākea Elementary: One (1) request for waiver days and one (1) request for kindergarten orientation (pages 17-18 of Attachment A);
- Waiākea Intermediate: One (1) requests for waiver days and **one (1) request for PTC** (page 18 of Attachment A); and
- Waikoloa Elementary and Middle: One (1) request for waiver days and **one (1) request for PTC held over 4 full days** (page 18 of Attachment A).

It is important to clarify that the waiver request forms and supporting documentation for all schools were submitted and reviewed appropriately by the Exception Review Committee (ERC), composed of Board designees and members of both the HSTA Bargaining Unit (BU) 05 and the Hawai'i Government Employees Association (HGEA) BU 06. The Department is currently adjusting the waiver process to prevent these types of technical gaps in the future. We are focusing on making the submission tools more user-friendly for schools, providing clearer instructions for leaders, and adding more internal review checks to ensure every request is captured and accurately processed.

This memorandum serves to correct the mislabeling and clerical errors in the official record and accurately reflect the ERC's intended approval of the waiver requests as written in Attachment B, which indicates the changes to the list of waiver requests approved on April 9, 2026.

b. Previous action of the Board on the same or similar matter:

On February 12, 2026, and April 9, 2026, the Board approved a total of 298 SCC waiver requests. The Board approved 269 requests to waive the number of student hours required in Section 302A-251, HRS, pursuant to Board Policy 106-5 Student Instructional Hours and SY Requirements Policy and Waiver Process. The remaining waivers were for other Board Policies or Department SP as outlined below.

c. Other policies affected:

- Section 302A-251, HRS: SY; student hours (180 days, 1080 student hours), Attachment C;
- Board Policy 102-15 High School Graduation Requirements and Commencement, Attachment D;
- Board Policy 500-26 New Student Orientation, Attachment E;

- SP 2404 Pre-Kindergarten and Kindergarten, Attachment G;
- Board Policy 101-12 Academic Requirements for Participation in Co-Curricular Activities, Attachment H; and
- HSTA CBA:
 - Article VI - Teaching Conditions and Hours, Sections D, E, R, X, Y, CC, DD
 - Article XV - Department and Grade Level Chairpersons, Section F
 - Article XVI - Work Year, Sections A, B

d. Arguments in support of the recommendation:

Hilo Intermediate, Konawaena Elementary, Waiākea Elementary, Waiākea Intermediate, and Waikoloa Elementary and Middle correctly followed the process to submit a waiver request by the second deadline, but due to oversight, their requests were incorrectly labeled on the list of schools presented to the Board at its April 9, 2026 GBM.

To address students' diverse learning needs and strengthen instructional practices, schools are requesting additional non-instructional days to train teachers and staff on critical school-level and complex-wide initiatives. Specifically, King Kamehameha III Elementary School is requesting a waiver day to help create a sense of belonging and collaboration amongst the whole school community. They will also use the waiver days to foster collective teacher efficacy through academic collaboration with other schools in the complex, specifically focusing on Career and Technical Education.

King Kamehameha III Elementary School submitted their waiver request forms prior to the second submission deadline, but due to a misunderstanding of the submission protocol, their documents were not included amongst the other 213 waiver requests that the Board reviewed and approved on April 9, 2026.

Waiver requests have been reviewed and approved by school administrators, HSTA members, HGEA members, SCCs, and respective Complex Area Superintendents (CAS), and thoroughly vetted by the SCC ERC.

e. Arguments against the recommendation:

All of the waiver/exception requests in Attachment A will result in a decrease of student hours. Fewer student hours may make it difficult for students, especially vulnerable learners, to make gains in their academic achievement.

f. Findings and conclusions of the Board committee:

The SCC ERC, composed of Board designees and members of both the HSTA BU 05 and the HGEA BU 06, has agreed to this request.

g. Other agencies or departments for the State of Hawai'i involved in the action:

None.

h. Possible reaction of the public, professional organizations, unions, Department staff, and/or others to the recommendations:

While there may be some concern with the loss of student hours, schools maintain that these requests are essential due to the high educational value of the proposed activities. All waiver requests are supported by a rigorous review process that incorporates community feedback. This includes approval from administrators, HSTA members, and SCCs at the school level, and by the CAS. Waiver requests have also been thoroughly vetted by the SCC ERC, composed of Board designees and members of both the HSTA BU 05 and the HGEA BU 06. Due to the opportunity for stakeholder input and a rigorous review process, the Department expects to receive support and positive reactions.

§302A-251 School year; student hours. (a) Notwithstanding any other law to the contrary, beginning with the 2011-2013 school years, all public schools, excluding charter schools and multi-track public schools, shall implement a school year of one hundred eighty days, excluding professional development days and other non-instructional days negotiated pursuant to chapter 89.

(b) Notwithstanding any other law to the contrary:

- (1) For the 2011-2012 school year, fifty per cent of all public elementary schools in the State, excluding charter schools and multi-track public schools, shall implement a school year that includes nine hundred fifteen student hours; and
- (2) Beginning with the 2012-2013 school year, all public elementary schools in the State, excluding charter schools and multi-track public schools, shall implement a school year that includes nine hundred fifteen student hours.

(c) Notwithstanding any other law to the contrary, for the 2015-2016 school year, all public secondary schools, excluding charter schools and multi-track public schools, shall implement a school year that includes nine hundred ninety student hours.

(d) Notwithstanding any other law to the contrary, beginning with the 2016-2017 school year, all public schools, excluding charter schools and multi-track public schools, shall implement a school year of one hundred eighty days, excluding professional development days and other non-instructional days negotiated pursuant to chapter 89, that shall include one thousand eighty student hours for both elementary and secondary school grades.

(e) The board, in its discretion, may grant a waiver to any individual school subject to the student hours or one hundred eighty day school year requirements in this section. The board shall adopt policies and procedures to grant a waiver under this subsection.

(f) For purposes of this section, "student hours" shall be inclusive of the full school day in alignment with the State's general learner

outcomes.

(g) The department of education, with the board of education and office of the governor, and in consultation with representatives of the affected collective bargaining units, shall submit to the legislature, no later than twenty days prior to the convening of the regular sessions of 2013, 2014, 2015, and 2016, a report on its progress and efforts to meet the requirements of subsections (a), (b), (c), and (d). POLICY 102-15

HIGH SCHOOL GRADUATION REQUIREMENTS AND COMMENCEMENT

A. Requirements for High School Graduation. The purpose of high school graduation requirements is to establish rigorous standards of learning that will enable all public school students to meet the vision of a Hawaii public school graduate. All Hawaii public school graduates will:

- Realize their individual goals and aspirations;
- Possess the attitudes, knowledge, and skills necessary to contribute positively and compete in a global society;
- Exercise the rights and responsibilities of citizenship; and
- Pursue post-secondary education and/or careers.

Students who demonstrate proficiency in the State Standards and General Learner Outcomes in the required courses or proficiency based equivalents shall receive a Hawaii High School Diploma. Proficiency shall be determined in accordance with established Department of Education procedures.

The minimum course and credit requirements to receive a high school graduation diploma are:

English	4.0 credits including English Language Arts 1 (1 credit), English Language Arts 2 (1 credit), and Expository Writing (0.5 credit) and 1.5 credits of common core aligned language arts electives or proficiency based equivalents
Social Studies	4.0 credits including U.S. History and Government (1 credit), World History and Culture (1 credit), Modern History of Hawaii (0.5 credit) and Participation in a Democracy (0.5 credit) and 1 credit of standards based social studies elective or proficiency based equivalent
Mathematics**	3.0 credits including Algebra 1 (1 credit), Geometry (1 credit) and 1 credit of common core aligned math elective or proficiency based equivalent
Science	3.0 credits including Biology and 2 credits of standards based science electives or proficiency based equivalents

World Language	2.0 credits in one of the specified programs of study or proficiency based equivalents
Fine Arts	
Career and Technical Education	
Physical Education	1.0 credit or proficiency based equivalent
Health	0.5 credit or proficiency based equivalent
Personal/ Transition Plan	0.5 credit

Total	24.0 credits

A Hawaii High School Diploma shall be issued to students who meet the course and credit requirements.

High school diplomas may be granted to 16-year-olds and 17-year-olds who have qualified for graduation through adult schools.

*DOE will establish a process for developing and approving all proficiency-based equivalents similar to the process followed for all other new Authorized Courses and Code Numbers.

** A series of courses that satisfy the minimum learning expectations for all students as delineated in the College and Career Readiness Standards that are encompassed by the Common Core State Standards ("CCSS") for Mathematics.

The graduation requirement for a high school diploma for students with disabilities shall be the same as students without disabilities.

B. Commencement Exercises. Commencement exercises may be scheduled any time after the last day of school for seniors. The last day of school for seniors shall be set by the Department of Education. Students shall be permitted to participate in commencement exercises if they: (1) meet the requirements for a diploma or a certificate; (2) have fulfilled their financial obligations; and (3) meet other conditions, established by the Department of Education, which meet the standards of clarity, reasonableness, and justifiability.

POLICY 500-26**NEW STUDENT ORIENTATION**

Secondary schools may establish a one-day orientation program on the first school instructional day which is attended exclusively by students in the incoming grade provided that:

1. The decision is approved by the school community council;
2. All staff report for a full day of work; and
3. All grade levels report for a full day of instruction on the succeeding day.

Orientation programs provided under this policy shall constitute a waiver to the student hours required pursuant to section 302A-251, Hawaii Revised Statutes.

Rationale: The transition to secondary school may be difficult and may cause stress and anxiety for both parents and students. School data indicate that students in the incoming grade level experience the most difficulty in school adjustment. A one-day orientation program on the first school instructional day attended exclusively by students in the incoming grade may be beneficial to the entire school community.

Teacher Responsibility: Teachers shall a) adhere to all DOE regulations, guidelines and procedures for student promotion and retention; b) help students and parents understand promotion requirements and reasons for retention; c) provide educational experiences of increasing complexity to help students attain identified benchmark expectations in meeting the HCPS; d) identify students needing CSSS services in a timely manner; and e) use the DOE Report Card form unless the school is granted an exception to this requirement.

SP 4510: Reporting Student Progress

1. **Purpose**

To require that reports of student progress be periodically provided to students and parents.

2. **Effective**

Immediately. This SP supersedes Regulation 4510.1.

3. **Applies to**

All administrators, teachers, registrars, and other instructional staff responsible for assessing and reporting student progress.

4. **Background**

The Board of Education (BOE) recognized that “evaluation and the communication of student progress serve to place value on learning and are critical to attainment of the Hawaii Content and Performance Standards (HCPS) and General Learner Outcomes (GLOs)” (see Reference (b) BOE Policy 4510). The BOE, therefore, requires that

parents and students receive periodic reports of student progress and that these reports be both diagnostic and constructive. It also requires all elementary schools to conduct parent-teacher conferences at least once each year and encourages all secondary schools to conduct parent-teacher-student conferences to update parents on their children's academic progress.

5. **Guidelines**

Progress Reports: Progress reports shall include information about the student's progress in meeting the HCPS and GLO's as well as indications of social and personal development. Schools shall issue formal reports but may also use less formal formats such as notes, telephone calls, email messages, etc.

Released Time for Student Conferences: Released time for elementary parent-teacher or secondary parent-teacher-student conferences are subject to the following:

- Dismissal of classes shall be limited to a) the hour immediately before the end of the school day; b) 10 days in any one school year; and c) be in consonance with bargaining unit agreements.
- The school administration shall use an appropriate means to determine that the majority of parents approves of the dismissal of classes for the purpose of holding conferences;
- Conference dates should be determined when the school calendar is developed so that parents can be informed of these dates in a timely manner;
- The school administrator must inform the Complex Area Superintendent (CAS), student transportation provider, cafeteria staff, and A+ provider, and others who may be affected by the early dismissal dates in advance of scheduled conferences;
- Formal or informal evaluation(s) for the purpose of assessing conference effectiveness and identifying areas for improvement should be conducted;
- Students whose parents are unable or unwilling to participate not be penalized; and
- Provisions should be made to supervise students in school when dismissal prior to the regular time creates undue hardship on parents.

Teacher Responsibility: Teachers shall a) participate in scheduled conferences as allowed for in the bargaining unit contract; b) provide information about the students' proficiency in meeting grade-level benchmarks for HCPS, show examples of student work to support this data, and as appropriate, identify ways parents can help their child better learn and attain the HCPS benchmarks.

Schools should use DOE progress report forms as they are made available for elementary and secondary schools.

SP 4520: Academic Requirements for Participation in Co-Curricular Activities

1. **Purpose**

To require students participating in co-curricular activities—including athletics—to have at least an overall 2.0 grade point average (GPA) and be passing all courses required for graduation.

2. **Effective**

Immediately.

3. **Applies to**

All high school students.

4. **Background**

Because the Board of Education (BOE) is committed to the promotion of high academic achievement, it determined that students who participate in co-curricular activities—including athletics—demonstrate academic achievement. After much discussion and public testimony, the BOE determined that the minimum requirement for participation will be a 2.0 grade point average (GPA) and passing in courses required for graduation (see Reference (b) BOE Policy 4520).

5. **Guidelines**

Definitions.

Participation is participation in the event and does not include participation in rehearsals, practices, or tryouts.

Co-curricular activities are synonymous with extracurricular activities and include student clubs, athletics, and events such as proms, winter balls, etc., but do not include field trips, marching band, and other *class-related* activities.

Core courses refer to the sixteen (16) courses required for graduation.

SP 2404: Pre-Kindergarten and Kindergarten

1. **Purpose**

To provide junior kindergarten and kindergarten programs to all children who meet entrance requirements and pre-kindergarten education to all-pre-school children, ages three to five, who have been determined to be eligible for services under the provisions of the Individual with Disabilities Education Act (IDEA).

2. **Effective**

Immediately. This SP supersedes Regulation 2404.1.

3. **Applies to**

All elementary schools.

4. **Background**

Hawaii Revised Statutes (HRS), Section 302A-1132 establishes compulsory school attendance requirements for Hawaii's children (see Reference (c), HRS 303A-1132. Act 219, Hawaii State Legislature Session 2004, changed the age criteria for kindergarten entry and established junior kindergarten (see Reference (d), Act 219. In addition, the Department of Education (DOE) has always provided pre-kindergarten education for children age three to five who qualify for services under the provisions of the Individual with Disabilities Act (IDEA).

The Board of Education (BOE), recognizing the positive impact kindergarten attendance has in promoting school readiness, supports these programs via BOE Policy 2404; Pre-Kindergarten and Kindergarten (see Reference (d) BOE Policy 2404).

5. **Guidelines**

Enrollment of Kindergarten Students: All elementary schools should offer qualified children access to a junior kindergarten or kindergarten program, following entry requirements established by Act 219 and HRS 304A-1132.

Enrollment Age: As required by HRS 302A-1132, elementary schools need to adhere to the following age requirements when registering students:

- a) **For Junior Kindergarten:** children must have birthdates August 2 through December 31 of the year they are five years old;
- b) **For Kindergarten:** children must have birthdates January 1 through August 1 of the year they are five years old.

NOTE: For information regarding students ages three to five who qualify for pre-school services under IDEA refer to SP 2160 and Special Education Website (See **Reference (d), BOE Policy 2160 and (h) Special Education website.**)

Registration: Use registration forms provided by the elementary school. Individual school websites may also contain information about their Junior Kindergarten and Kindergarten programs.

Transition/Orientation: Elementary schools need to have a transition process in place to help families and staff ensure that the child's transition from home to junior kindergarten/kindergarten and from junior kindergarten to kindergarten is as smooth as possible. Whenever feasible, this transition process should include orientation for parents and new students. Schools should ensure that a) the orientation does not exceed five school days; b) parents/legal guardians are informed of the purpose of the orientation and the critical role they play in the education of their child; and c) parents/legal guardians are provided information about the orientation session's schedule and purpose no later than two weeks prior to the orientation date for their child.

Complex Area Superintendent Responsibility: The Complex Area Superintendent should approve any variation from the transition procedures stated in the section above, especially those related to the orientation schedule.

Developmentally-Appropriate Teaching Strategies: The junior kindergarten and kindergarten program should be student-centered and provide developmentally appropriate teaching strategies and learning activities (see Reference (b), BOE Policy 2235).

Assessment: Assessment of young children is complex and must adhere to best practice and knowledge of young children. In addition, schools must have a clear purpose and plan for the collection and use of assessment information.

Assessments must a) benefit the children and adults who work with children; b) be used for the purposes for which they are designed; c) provide useful, valid and reliable data;

and d) include the developmental domains of young children and multiple tools to gather data.

Movement Between Junior Kindergarten and Kindergarten Programs. Schools may, in consultation with the parent, move students between the junior kindergarten and kindergarten programs as deemed appropriate.

SP 2406: Middle Level Education

Students participating in co-curricular activities must have at least an overall 2.0 grade point average ("GPA") and be passing in courses required for graduation. "Participating," as used in this policy, does not include participation in rehearsals, practices, or tryouts. Activities which are essential and integral to any particular course are not affected by the policy.

The Department of Education shall establish guidelines to implement this policy.
